- 1. I am directed to invite your attention to Haryana Govt. letters noted in the margin on the subject noted above vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Domicile for the purpose of admission to educational institution (including technical/ medical institution). The matter has been reconsidered in the light of judgment delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain vs. Union of India and others reported as AIR 1984-SC-1421, wherein it has been held that instead of the word 'Domicile' the word 'Resident' be used in the instructions issued by the State Government and it has been decided to revise the Government instructions. Henceforth, the following categories of persons would be eligible for the grant of Resident Certificate:
 - i) Candidates, who have passed the examination qualifying them for selection in an institution from a school/college in Haryana.
 - ii) Children/Wards (if parents are not living)/Dependents:
 - a) Of the employees of Haryana State posted in or outside Haryana State or working on deputation;
 - b) Of the employees of the statutory bodies/ corporations established by or under an Act of the State of Haryana who are posted in Chandigarh or in Haryana or outside Haryana;
 - c) Of the employees of the Government of India posted in Chandigarh or in Haryana in connection with the affairs of the Haryana Government.
 - iii) Children/ Wards (if parents not living)/ dependents of persons who after retirement have permanently settled in Haryana and draw their pensions from the treasuries situated in the State of Haryana.
 - iv) Children/ Wards (if parents are not living)/ dependents of pensioners of Haryana Government irrespective of the fact that the original home of the retiree is in a State other than Haryana or he has settled after retirement in or outside Haryana.
 - v) Children/Wards (if parents are not living)/ dependents or persons, who have permanent home in Haryana and include persons who have been residing in Haryana for a period of not less than 15 years or who have permanent home in Haryana but on account of their occupation they are living outside Haryana.
- vi) The wives of such persons who are bonafide residents of Haryana irrespective of the fact that they had belonged to any other State before marriage.
- vii) Persons who were born in Haryana and produce a certificate to that effect; provided that the parents/ guardians (if parents are not living) of persons belonging to any one of the above mentioned categories are

- Citizens of India; a)
- Produce an affidavit to the effect that they or their children/ wards (if parents are b) not living)/ dependents have not obtained the benefit of Resident in any other State.
- All candidates claiming to be bonafide residents of Haryana should produce a Haryana Resident Certificate signed by the District Magistrate/ General Assistant to Deputy Commissioner or Sub-2. Divisional Officer (Civil) of the District/ Sub-Divisions to which the candidates belong. Resident Certificates in respect of elsewhere or in respect of the Children/ Wards/ Dependents of Haryana Govt. employees who are posted at Chandigarh, Delhi or elsewhere or in respect of Children/ Wards/ Dependents of pensioners of Haryana Govt. or in respect of the Children/ Wards/ Dependents of the employees of the Government of India posted at Chandigarh or in Haryana in connection with the affairs of Haryana Government, or in respect of Children/ Wards/ Dependents of the employees and retirees of the Statutory Bodies/ Corporations of Haryana established by or under an Act of the State of Haryana or a Central Act and located at Chandigarh, Haryana or outside Haryana, should be by their respective Heads of Departments.
- Candidates seeking admission in educational institutions (including medical and technical institutions) located in Haryana may not be required to produce Resident Certificate, if they 3. have passed the examination from a school/ college situated in Haryana. For this purpose, a certificate of the Principal/ Headmaster from concerned institution where the Children/ Wards studied last should be considered sufficient. The Principal/ Headmaster of the institution shall be competent to issue such certificate, which should be sufficient.
- If a candidate is admitted on the basis of claim that he belongs to the State of Haryana but at any subsequent time is discovered that his claim was false, the student shall be removed from 4. the institution, all fees and other dues paid up to the date of such removal shall be confiscated. The Principal/ Headmaster may take such other action against the student and his/her parents/guardians as he may deem proper in the circumstances of any particular case.
- For the purpose of uniformity for issuing certificate of Residence in the case of various 5. categories to be issued by the competent Authorities, proformas have been prescribed which are enclosed herewith.
- These instructions may kindly be noted carefully for compliance and the receipt of this letter 6. may please be acknowledged.

- 1. I am directed to invite your attention to Haryana Government letter Nos. 62/17/95-2GSIII, dated 03.10.1996, No. 22/51/93-3GTSIII, dated 12.08.93 and even No. dated 14.10.97 on the subject noted above wherein instructions regarding the Caste Certificates (SC/BC/OBC), and Resident Certificates been The policy has been reviewed keeping in view the various courts judgements and hardships caused to the individuals in obtaining above quoted certificates. Government is of the view that the procedure be institutionalized by delegating powers at proper level for ensuring speedy disposal of work without any harassment or exploitation. The present modification of the policy also aims at simplifying the procedure for obtaining certificate by an individual falling
 - 2. The matter has been reconsidered in depth by the State Government in view of the problems being faced by the Government employees in obtaining these certificates. With a view to improve the existing system in issuing various certificates, it has been decided by the Government that henceforth Circle Revenue Officers (Tehsildars/ Naib Tehsildar-cum-Executive Magistrate) concerned will be authorized to issue Resident as well as Caste Certificate (SC/BC/OBC) after getting the verification done through the subordinate revenue staff in case of applicants residing in the rural area and through the Corporation concerned in case of applicants residing in urban areas. It has further been decided that in case of Haryana Government employees serving in the offices located at Chandigarh/ Panchkula and residing at Chandigarh/ Panchkula, the Certificate and the Caste Certificates to SC/BC employees and for their children .may be issued by their respective Heads of Departments also.
 - 3. The validity of Resident Certificate issued by the competent authority shall be as long as the holder of this certificate maintains his residential address in Haryana State.
 - 4. SC certificate once issued be valid as long as the caste is not removed from the Schedule of the Constitution and BC certificate shall be valid for life from the date of issue of the certificate or till the applicant does not fall into creamy layer category as defined from lime to time. The applicant applying for BC certificate would also submit a self declaration on simple paper that he does not fall under creamy layer category. However, if the certificate has been obtained by fraud or misrepresentation or concernment of facts or by some other means, the said certificate shall be declared as invalid non-est and beacht taken by the applicant will be

withdrawn and a criminal case shall be registered against the applicant misrepresenting the facts as well as against the guilty officers/ officials, if any. In addition, Social Justice & Empowerment Department, Haryana is being directed to finalize the modalities and procedure to constitute the

The files relating to Caste and Resident certificate shall be retained for 10 years and Register shall be retained permanently. The proformae of the application form, Register and SC/BC certificates prescribed by the Government shall be followed by all the Departments/ Institutions in letter and spirit as it has come to the notice of the Govt. that some Department/ Institutions demand such certificates in proformae which are at variance with the proformae in which these certificates are being issued by the competent authorities (Tehsildar/ Naib Tehsildar/ HODs). It is, therefore, decided that the Departments/ Institutions shall accept hese certificates only in the proformae in which these are being issued by the competent authorities which have been prescribed by the Govt. itself.

To make institutional arrangements, it has also been decided that in future the Resident and Caste certificates will be issued to all the students studying in class 8th every year as per the time schedule given below :-

In the event of quota reserved for Physically Handicapped remain unutilised due to non-availability for suitable category of Handicapped Candidates, it may be offered to the Ex-Servicemen and their wards (1%) and the dependents of Freedom Fighters (1%).

Further, 3% reservation is also provided to Ex-servicemen/ Freedom Fighters and their dependants by providing reservation within reservation of 1% of General Category, 1% out of Scheduled Caste and 1% from Backward Classes category for admission to the various educational institutions of the Govt. and Govt. aided / Institutes located in Haryana. As far as Block allocation in Block-A and Block-B of Backward Classes category is concerned year wise rotational system will be adopted. Further, a roster register for reservation of seats for ex-servicemen/freedom fighters shall be maintained and carry forward all fractions, till one seat is accumulated through different fractions over the years. As and when the total comes to one, a seat will be provided.

Fifty percent of the twenty percent seats reserved for Scheduled Castes for admission in any educational institution shall be set aside for candidates belonging to deprived Scheduled Castes as enumerated in the Appendix-K1.

Where a seat is set aside for candidate from the deprived Scheduled Castes for admission in Government Educational Institution is not filled up in any academic year due to non-availability of candidate of the deprived Scheduled Castes possessing the requisite qualification, the same shall be made available to the candidate of Schedule Castes.

GUIDELINES FOR RESERVATION

- The reservation of seats is as per the Reservation Policy of Haryana Govt. and is subject to change/amendment made by the State Govt. from time totime.
- Candidates belonging to SC/DSC/ST are required to submit a certificate from the competent authority as per Appendix-C. The list of Scheduled Castes notified by the Haryana Government, is available at Appendix-K.
- 3. Candidates belonging to Backward Classes are required to submit a certificate from the competent authority as per **Appendix-D**. Circular no. 1170-SW(1)-95 dated 07.06.1995 & No.213-SW(1)-2010 dated 31.08.2010, No.22/22/20043 GS-III dated 14.06.2016 and Haryana Government Welfare of Schedule Castes and Backward Classes Department Notification No. 1282-SW (1) dated 28.08.2018 be followed.Instructions for Gross Annual Income may be referred in Govt. notification dated 28.08.2018. The list of Backward Classes in Haryana notified by the Haryana Government, is available at **Appendix-I**.
- The children or grand children (Maternal & Paternal) of Freedom Fighters are required to submit a certificate from the competent authority as per**Appendix-E**.
- Only those candidates who have permanent disability of not less than 40% (being otherwise fit for admission to the program) will be considered for admission as Physically Handicapped. They will submit a certificate from the competent authority as per **Appendix-H**. Disability Certificate shall, however, be subject to verification by a Medical Board to be constituted by the University. The decision of Medical Board in this regard shall befinal.
- Children or Wards of Military Personnel (including personnel of Para-Military Forces killed in Action or Permanently Disabled in Action and Boarded Out from the Services or Ex- Servicemen and their wards will be considered for reservation. They will submit a certificate as per **Appendix-F**. The following categories of personnel of Territorial Army are included in the definition of Ex-Servicemen in terms of the State Govt. A candidate who applies for a reserved category will be considered first in general category on the basis of merit. In case, he/she is not selected in general category, he/she will be considered for reserved category.

The Scheduled Castes/Backward Classes candidates who get selected /admitted in Educational/Professional/Technical Institutions and Universities in open competition on the basis of their own merit, will not be counted against the quota reserved for scheduled caste/ backward classes, rather they will be treated as open competition candidates. However, such candidates shall fulfill condition of eligibility regarding age etc. as are meant for general category candidates (Memo No.13864-75 dated 24.8.2012 received from the PrincipalSecretary to Govt. of Haryana, Welfare of Scheduled Caste and Backward Classes Department, Chandigarh).

- If any seat remains vacant in sub-categories of BC (A) and BC (B), the same will be filled up through the candidates belonging to other category. For example, if any seat in BC (B) category remains vacant, the same will be filled up from BC (A) category and vice-versa.
- If any seat remains vacant in sub-categories of SC and DSC, the same will be filled up through the candidates belonging to other category. For example, if any seat in SC category remains vacant, the same will be filled up from Deprived SC category and vice-versa.
- Benefit of reservation will be given to all the reserved categories upto 3rd counseling according to the reservation policy given in the Prospectus. In case at the time of 3rd counseling the reserved seats of various categories remain vacant and no eligible candidates of the reserved categories are available then these vacant seats may be thrown open to Haryana General Category by the concerned Head of the Department/Director at his/her own level. In case, the seats in Haryana General Category remain vacant at the end the same will be thrown open to All India Open Category by the Concerned Head of the Department/Director at his/her ownlevel.

5.5 NRI Quota Seats:

In compliance of the judgment dated 12.08.2005 of Hon'ble Supreme Court of India in PA Inamdar case, a limited reservation of NRI Seats, not exceeding 15%, may be made available to NRIs depending on the discretion of the Management subject to two conditions:

- 1. Such seats should be utilized Bonafide by the NRIs only and for their children or wards.
- 2. Secondly, within the quota, the merit should not be given a complete go-by.
 - (a) The amount of money, in whatever form collected from such NRIs, should be utilized for benefitting students such as from economically weaker sections of the society, whom, on well-defined criteria, the educational institutions may admit on subsidized payment of their fee.
 - (b) To prevent mis-utilization of such quota or any malpractice referable to NRI quota seats, it will be for the committees constituted pursuant to Islamic Academy's direction i.e. under the Chairmanship of Hon'ble Mr. Justice R.K. CHAPTER-7 IMPORTANT PROCEDURES FOR SESSION 2021-22

7.1 PROCEDURAL STEPS FOR PARTICIPATING IN ONLINE OFF CAMPUS COUNSELING

- 1. This procedure is applicable for the candidates who want to take admissions through
- 2. Candidates should go through information brochure for gathering detailed information about counseling schedule and procedure. Softcopy is available on the websites www.hstes.org.in website visit
- Rs.500/of counseling fee https://techadmissionshry.gov.in and click on "Payment Registration" / generate your 3. For Roll no. and deposit the counseling fee through Credit/Debit Card or Net banking by using online payment gateway.

(Remember you have paid your counseling fee before proceeding for online counseling, else your allotted seat can be CANCELLED at any stage and candidate would not have any claim on such allotted seat.)

- all Government/Private Technical Courses in B.E./B.Tech. Institutions/State Universities shall be filled against 15% Rest of Haryana Quota 4. The seats in (excluding Haryana State) upto 2nd Online Counseling. After 2nd Online Counseling all the vacant seats under this Rest of Haryana Category (RoHC) shall be made in General Category to all the candidates including Haryana in subsequent counseling.
 - 5. Two online counseling will be conducted for admission to B. Tech. course for all the seats of University Departments, Govt./Govt. Aided Institutions and 75% seats of Self Financing Institutes as follows:

1stcounseling: shall be done for all categories namely RoHC, HOGC, SC, SCD, BCA, BC-B, PH, ESM (with all priorities) and FF of all categories with 25% Horizontal Female reservation.

2nd counseling: shall be done for all categories namely RoHC, HOGC, SC (by merging SC and SC-D in SC), BC (by merging BCA and BCB in BC) and merging all ESM (all priorities) and FF with 25% Horizontal Female reservation.

For the supernumerary seats i.e. Tuition Fee Waiver (TFW) and Economically Weaker Section (EWS) seats, online counseling will be done parallel to above counseling on the basis of JEE (Main)-2024 rank. For kashmiri Migrants (KM), online counseling will be COORDINATOR

done parallel to above counseling on the basis inter-se-merit of qualifying exam.

6. After 2nd counseling no online counseling shall be conducted by HSTES and admission shall be made at Institute level counseling after merging the sub categories (including female) of a particular reserved category into the main reserved category. In event of seats remaining vacant/unfilled, if any, same shall be filled up before final cut-off date of admissions without any reservation, firstly on the basis of entrance exam merit and only thereafter on the basis of marks of qualifying examination.

Steps for Participating in Online Counseling:

- 1. For participation in online counseling (ID Verification, registration, submission of choices, downloading of seat allotment letters etc.), candidate will visit the website www.techadmissionshry.gov.in from any internet point preferably from any of the technical institutions in the states . (Avoid going to Cybercafés, as they may mislead or misguide you).
 - 2. On website, www.techadmissionshry.gov.in, view general information about institutions profile, cut off ranks, latest schedules of counseling etc.
 - 3. To start counseling click on "New registration" option and submit your details of Course, Roll number, application number, Name, Date of birth (as per JEE-Main admit card in case of B.E./B. Tech. Course and NATA-2021 admit card in case of B. Arch. Course) OR details provided by HSTES.
 - 4. In case your entered details are wrong, software will not allow you to submit. You may contact to HSTES for its rectification, if any.
 - 5. If all information is entered correctly, you will get registration page for registering yourself as follows:

7. After this, candidate will be redirected to "Registration Confirmation" page where all entered registration details are displayed for confirmation once again. If you found any detail incorrect, that can be corrected by using the option "edit registration details" otherwise "Click here to continue", if all the registration details shown are correct.

- 8. Once you proceeded from the above step, your registration details can't be changed or edited, so click on "Registration Confirmation "page when all your particulars are correct. In exceptional case, you may have to visit/contact HSTES only.
- 9. If any of the details are incorrect, please check the details once again. For any correction/verification, you may contact HSTES on toll free number 18001373735.
- 10. The candidate shall upload his/her following certificates/ documents to participate in Centralized Online counseling on website www.techadmissionshry.gov.in, as per key dates:

Note:- Candidates, who has passed his/her qualifying examination from a Board/ Recognized School situated in the State of Haryana will be deemed to be Haryana resident and will not be required to submit certificates of bonafide. residents of Haryana.

- Relevant Kashmiri Migrants (KM) certificate in the support of their claim from V. the competent authority or Relief Commissioner.
- Relevant certificate of HGST (Haryana Govt School Topper) as per Annexure-VI. XIII.
- 11. You can generate a User ID and Password. Candidates should strictly keep records of this password for their own use only and not to disclose this to others. In the event of sharing of password, candidate will be solely responsible for the change of registration details, choice etc. In the event of losing or forgetting of password, the same can be retrieved by the candidate on replying the queries by the system on the counseling website.
 - 12. Candidate will login the website www.techadmissionshry.gov.in with his chosen User ID/Password. After this, Candidate will confirm his/her registration details and move to fill his/her eligible choice. Registration confirmation is necessary for choice filling.
 - 13. Candidate can also see his eligible choices and can take the print out of his/her eligible Choices. Number of seats available in an institution will be displayed as per the eligibility/category. The non-availability of a seat in an institute for which a candidate is not eligible will not be displayed to him / her. Director,

- 14. Candidate will fill his /her choices by clicking on Fill/Modify choice and fill his/her Choices priority wise by clicking on add choice button (+) in left frame. Candidate should save the filled choices also.
- 15. To increase the probability of getting a seat, candidates are advised to fill maximum eligible choices.
- 16. After filling the choices, Candidate will lock his/her choices. Locking choices means Candidates finally filled his /her choice.
- 17. Candidate can unlock his/her choices and can edit, sort his/her choices in specified time period which is available on key date's link (choice locking starts, choice locking ends) on the website. Candidate should lock his/her filled choice for seat allotment result.
- 18. In case candidate make changes in his/ her-registration details, he/ she has to fill the choices again as previous choices will be deleted automatically by the system as soon as any changes is made in registration details.
- 19. After this, Candidate has to wait for result of desired course as per key dates.
- 20. Seat Allotment Result publishing date is available on Key date's section on the website.
- 21. After the declaration of result, candidate will log in to the counseling website www.techadmissionshry.gov.in by entering his/her Roll No. & Password and click on Provisional Seat Allotment result. If candidate has been allotted a seat then a page showing provisional seat allotment letter appears which shows Institute name, branch allotted to a candidate, Allotment Status and reporting duration.
- 22. Candidate should download Provisional Seat Allotment letter, and should online report to allotted institute between specified reporting dates for taking admission.
- 23. Candidates who are willing to take admission in the allotted institution should report online offline and deposit online admission and tuition fees of Rs.

10,000/- (Rs. 1000/- for SC/SCD) as a token fees in the account of HSTES during the process of reporting alongwith the application fee (as mentioned in key dates) and counseling fees (as mentioned in key dates) if already not paid, to take admission in the allotted institute. However, the confirmation of Provisional Admission will be done after verification of uploaded documents by the allotted institute.

Note: The candidate will deposit the remaining (as mentioned in **Appendix-F**) admission and tuition fee as and when physically join the allotted institute.

- 24. After that the candidate will obtain the Provisional Admission Slip from institute, and in this way candidate can reserve a seat.
- 25. For up gradation of the allotted seat, a candidate should participate in subsequent counseling.
- 26. For that the candidate will login on website <u>www.techadmissionshry.gov.in</u> and click on the undertaking that "I understand and accept that, by participating in this counseling, my earlier admission/allotment, if any, will be cancelled automatically, in case I get new allotment of seat by participating in next counseling".
- 27. Candidate has to check the undertaking and click on Accept Participation and Proceed to participate in further counseling. Candidate is advised to ONLY opt for the choice(s) which is/are better than the seat reserved in previous counseling. Thus candidates are advised to fill the choices in order of priority only to upgrade. The candidates who wish to retain the reported seat are advised not to opt for subsequent counseling. However, if a candidate participates in the 2nd Counseling and after filling the choices he/she feels that he/she should not have opted for 2nd counseling then at this stage he/she should delete all the choices filled by him/her to retain the seat reported through 1st counseling.
- 28. If candidate wants to change his/her registration details, then candidate has to approach HSTES for modification in his/her registration details along with relevant certificates. By changing registration details, candidate filled up choices, if any, would be deleted and eligible choices of candidate may be affected.

29. For all subsequent counseling's, step 11 to 28 will repeat.

Things to Remember

- > In case a candidate gets a new seat in subsequent counseling, the earlier allotment/admission, if any, stand cancelled automatically.
- ➤ In case a candidate upgrades to a new discipline in the same institution, he/she should report again in the allotted institution but need not to deposit one semester fees again.
- > If a candidate upgrades to a new institute in subsequent online counseling, then candidate need not to deposit online semester fees again for the new allotted seat, although candidate will confirm his/her acceptance of seat at the newly allotted institute. If not accepted then both the seats stand cancelled. In case of cancellation of online provisional admission, candidate should submit fee withdrawal request to the
 - > The candidates who did not get seat in previous counseling or who are not satisfied with the allotted seat may try in subsequent counseling for getting a seat or upgradation as per the case respectively.
 - > Once the seat is allotted in subsequent counseling, the previous allotted seat will automatically be cancelled.
 - > After allotment of seat in subsequent counseling, the candidate must report at the allotted institute and in case of non-reporting by the candidate, the allotted seat will also be cancelled automatically (previously allotted seat got cancelled due to new allotment of seat in subsequent counseling and newly allotted seat got canceled due to non-reporting) and that seat will be automatically offered to the candidates in the next subsequent counseling. Previously allotted seat will not be given to candidate by any means after allotment of seat in the subsequent counseling even if it remains vacant.

 - Kashmiri Migrants, Haryana Govt. School Toppers, Economically Weaker Section, Tuition fee waiver scheme candidate shall register online and fee for the purpose shall also be deposited online through https://onlinetesthry.gov.in. and upload the desired documents as per the procedure mentioned at Chapter-3.
 - Kashmiri Migrants condidates will be required to have the original certificate of COORDINATOR

Migration duly signed by the competent authority or Relief commissioner.

- The candidate applying for Tuition Fee waiver Scheme will produce the relevant
 Income Certificate issued by the competent authority (Annual income of Parents
 / Guardians should be less than Rs.8.00 lakh from all sources). Counseling for
 Tuition Fee Waiver Scheme seats shall be done online for all institutions approved by
 the AICTE.
- The candidate applying for Economically Weaker Section (EWS) will produce EWS Income and Asset Certificate issued by the competent authority.
- In case of Haryana Government School Topper (HGST) of B. Tech. Course, the candidates will produce a certificate, as per Annexure-XIII, in the support of their claim from the Principal/Headmaster of the Govt. School of which the candidate is topper clearly stating the strength of class etc. They should also show the original mark-sheet along with them during time of reporting at the time of admission in the Institute. They are required to pay counseling fee of Rs. 500/- (non-refundable) through https://techadmissionshry.gov.in and after the display of merit list for the eligible candidates, they are required to participate in counseling through https://techadmissionshry.gov.in.
- Candidates applying for *TFW* are required to fill Application form Online, available at website https://onlinetesthry.gov.in (in case of B. Tech) on the basis of Roll No. of JEE Main 2021. After the display of list of the eligible candidates for TFW Category, they are required to deposit separate counseling fee of Rs.500/- (non-refundable) to participate in counseling through https://techadmissionshry.gov.in.

7.3 COUNSELING PROCEDURE FOR ADMISSION TO B.ARCH. COURSE

- 1. The admission seeker for B. Arch Course need to apply online at https://onlinetesthry.gov.in and shall upload his/her Score card of valid NATA 2021 (PDF of Max 200 KB Size) and detailed marks certificate of Qualifying exam (PDF of Max 200 KB Size) on online application form on website www.onlinetesthry.gov.in.
- 2. However, the relevant documents/credentials as mentioned in Chapter-8 shall also be required at the time of physically joining the Institute; otherwise allotted

seat will be cancelled by the reporting institute

- 3. The Merit list (B. Arch) shall be displayed on the website <u>www.hstes.org.in</u> as per **"Key Dates".**
- 4. EWS Candidate will apply on https://onlinetesthry.gov.in and upload the Income and Asset Certificate for EWS issued by the competent authority alongwith other requisites documents and shall register on www.techadmissions.hry.gov.in separately and pay counseling fee @ Rs. 500 separately.

Note: The candidates are required to pay counseling fee of Rs.500/- (non-refundable) through https://techadmissionshry.gov.in and after the display of merit list for the eligible candidates, they are required to participate in online counseling through https://techadmissionshry.gov.in.

- 7.4 COUNSELING PROCEDURE FOR 25% SEATS IN CASE OF B.E./B. TECH & B. ARCH COURSE TO BE FILLED BY THE PRIVATE INSTITUTIONS INCLUDING LEFT OVER/UNFILLED SEATS OF ONLINE COUNSELING TO BE FILLED BY ALL CONCERNED INSTITUTES AT THEIR OWN LEVEL.
 - 1. Private institutions shall fill 25% seats (including 15% seats for children/ wards of NRIs) in B. Tech. and B. Arch. courses at their own level in a just and transparent manner for which they shall invite the applications, prepare and display the merit list. The procedure shall be displayed by the Institute concerned on its website.
 - 2. All institutions shall fill left over/ unfilled seats of online counseling at their own level in a just and transparent manner as per the judgment of Hon'ble Supreme Court in Civil Appeal no. 9048 of 2012 titled as Parshavnath Charitable & Ors Vs. AICTE & Ors. For this the institute shall dully advertise and notify the leftover/vacant seats and shall invite the applications, prepare and display the merit list. The procedure shall be displayed by the Institute concerned on its website and in newspapers.
 - 3. All the institutions shall make these admissions before final cutoff date of admissions and no institute shall be allowed to make admission after Last cut off date i.e. the last date fixed by Hon'ble Supreme Court or AICTE.
 - 3. The minimum eligibility condition for these seats shall remain the same as that for 75% seats to be filled by the Haryana State Technical Education Society.

- 5. In the event of seats remaining vacant in B.E./ B. Tech course, if any, the vacant seats may be filled up before final cut of date admissions firstly on the basis of JEE- MAIN. 2021 merit and only thereafter on the basis of marks of qualifying examination.
- 6. In case of B. Arch, seats remaining vacant, if any, the vacant seats may be filled up before final cutoff date of admissions on the basis of NATA-2021 merit only i.e. valid NATA-2021 score and marks secured in the qualifying examination in the ratio of 50:50.
 - 5. In any case all kind of admissions shall be done before the final cut-off date admissions (as mentioned in key dates) and the fee fixed by the State Fee Committee shall be charged as per the laid down procedure. In any case higher fee shall not be charged.
 - 6. The final list of admitted candidates (including the institute level admission) should be uploaded online on www.intrahstes.gov.in by the institutes by the last cut of date of admissions, positively, so that the same may be forwarded online to the concerned Universities. The wrong admissions, whatsoever, shall not be permitted.
 - Admission Data Management Fee (Rs.200/- per admission) shall be charged one time by HSTES in respect of all admissions (Centralized Admissions and Institute Level admissions) in Self Financing Institutions including un-aided branches of Aided Institutions from the academic session 2016-17 onwards. The said Fee be charged from the admitted students by the concerned institute and be credited/deposited in HSTES account.
