The Anti-Ragging Squads will chalk out the programme of raids at different hostels at different timings in consultation with Dr. Ashvani Goyal, Convener, Anti Ragging Committee. In the event of any case of ragging the same must be reported immediately to the Convener, Anti Ragging Committee so that strict disciplinary action is taken immediately against the defaulter.

The freshers as well as the seniors must be counselled by the Anti-Ragging Squads and the Anti-Ragging Committee. The seniors should be advised to desist from indulging in anti-ragging lest they may lend themselves in serious trouble which can also lead to criminal proceedings against them. The freshers and senior's students should also be enlightened about the actions/behavior which will be termed as the acts of ragging and the possible disciplinary actions against ragging.

The Convener, Anti Ragging Committee should also organize orientation courses for fresher's and also advise them to immediately report to any member of the Anti-Ragging Committee/Squads in case of any incident of ragging
